### The Law Enforcement Council

The Law Enforcement Council (Council) is tasked with the general inspection of the effectiveness, quality and management of the judicial organizations, and the judicial cooperation between the BES islands, Sint Maarten and Curacao.



# **Overarching topics Sint Maarten**

Several topics of concern inspections 2023:

- Lack of steering by the Minister and Ministry of Justice.
- Legal position justice personnel not yet finalised.
- Tier 3 status third year in a row (Trafficking in persons report, U.S. Department of State)

The Council has established that cooperation between the countries in the Kingdom is being sought in many areas.

### Processing of police data

Status: The Council began the process of mapping out its oversight role in regard to the processing of police data in 2023 and has continued this process in 2024.

# **Detention & monitoring CPT** recommendations

Status: The Council initiated this inspection in 2023, but based on exploratory interviews, desk research and developments to date, chose to limit it to monitoring developments in this area. In 2024 an evaluation will take place and a decision will be made as to when further research will be carried out.

#### Arrest team

Year report: 2023

Recommendations: 9

Main concerns:

- Lack of support by administrative authorities for the necessary financial, human and material capacity for the outfitting of a professional Arrest team.


# Human trafficking & human smuggling and the prostitution policy and its enforcement

- Approach to human trafficking and human smuggling is still inadequate
- Insubstantial progress has been made with regard to the prostitution policy and its enforcement in Sint Maarten.

Main concerns:


- Where follow-up of recommendations is dependent on the Ministry of Justice, that follow-up is stagnant.




